Presentation by project applicant and/or representative; public comment; discussion by Committee; possible motion/recommendation to the PPCC board.

Applicant filed a City Planning case on 1/26/18 requesting 2 off-menu Density Bonus items to allow a 5-sty, 60' tall bldg., w/ 2:1 FAR, in lieu of code-permitted 30' height and 1:1 FAR. The project is proposed as 3,000 SF of retail space and 40 dwelling units. Per City requirements, 49 parking spaces are proposed (37 residential and 12 commercial), plus 57 bike parking spaces.

This is the second presentation and discussion of this project. Previous presentation was August 23, 2018. See 2018 LUC Report & Project Plans.
