### **Retention of Advisor Not Favored by Chair**

Two-thirds of Board members voting. Art. V.D.

# **Disciplinary Actions**

Secret ballot; two-thirds of Board members present. Arts. XV.6 and XV.7

### **Bylaws Amendment**

Two-thirds of Board members present. Art. XII.2.A

## Addition of New Organizations to Appendix A

Two-thirds of entire Board.<sup>5</sup> Art. VIII.1.A.4

### Appendix C (Standing Rules) Amendment

Majority of Board members present. Art. XVI

<sup>&</sup>lt;sup>3</sup>Under the "members present" rule – unlike the "members voting" or "votes cast" rule -- abstentions effectively count as no votes.

<sup>&</sup>lt;sup>4</sup>Under this rule the required vote is based on the entire Board membership number, not the number of members present at the meeting. In PPCC's case, there are 23 voting members; thus, a 12-vote majority is always required to replace an officer in the event of a vacancy.

<sup>&</sup>lt;sup>5</sup>Under this rule, a 15-vote majority (2/3 of 23) is always required to add new organizations to Appendix A. See Art. X.2.A
