[Pacific Palisades Community Council] recommends the following reform: Eliminate the "gut and amend" bill process and request the City of Los Angeles include in its Sacramento legislative priorities the elimination of the "gut and amend" bill process.

Example of gut-and-amend bill in immediate past legislative session:

SB 474 (Stern) -- originally a "wildlife protection" bill to *amend the Fish & Game Code;* passed in the Senate last year, went to Assembly and was put on hold; Sen. Stern then replaced the text this year with entirely different bill language, now to *prohibit all new development in the VHFHSZ* (status: bill not taken up this session by 2<sup>nd</sup> required Assembly committee; unknown whether bill will go forward in next session); see:
