Solid Waste Management – City of Los Angeles 4 Million Residence



750,000 - Single Family homes & small multifamily complexes as well as city facilities

6 Franchise Haulers aka



65,000 Accounts -Medium & large multifamily complexes, condo buildings and commercial businesses

LA Sanitation & Environment

- LASAN's solid waste services include :
 - Blue-Bin for recyclables
 - Green-Bin for yard trimmings
 - Brown-Bin for horse manure
 - Black-Bin for refuse
 - Unlimited Bulky Item Collection
 - Dead Animal Collection
 - Mattress Recycling
 - Used Tire Recycling
 - Household Hazardous Waste (SAFE Centers)











Blue-Bin Program

- Collects an average of 840 tons per day of recyclable materials
- Materials accepted in the bin include:
 - Paper
 - Cardboard
 - Plastic products (1, 2 & 5)
 - Glass bottles and jars
 - Metal (aluminum, tin)













NOT Accepted in the Blue-Bin

NO TO THESE PLASTICS These plastics should now be disposed in the Black Bin:

- PLASTIC #3: POLYVINYL CHLORIDE
 Clear food wrapping, teething rings, kids and pet toys
- PLASTIC #4: LDPE
 Shrink wrap, dry cleaner bags, plastic shopping bags, squeezable bottles, bread packaging bags
- PLASTIC #6: POLYSTYRENE
 Disposable cups, utensils, food containers (both rigid and foam),
 egg cartons, foam packing material
- PLASTIC #7: OTHER
 Polycarbonates and LEXAN- water bottles, food containers, Bioplastics (PLA),
 disposable packaging, utensils, straws, cups, bags, bottles

Special note: Bioplastics, which are derived partly or wholly from plants, are NOT recyclable in Los Angeles. Bioplastics are used in disposable items like packaging, containers, straws, bags and bottles. They may be marked "0" or "7" or "PLA."

Processing and Marketing

 LASAN delivers the materials to a Material Recovery Facility (MRF).

At a MRF, recyclables are:

- Separated and sorted by material using equipment such as powerful magnets, screens, and manual labor
- Baled materials are transported and shipped for sale to recycle into new products
- Contaminated materials are removed and landfilled appropriately

Green-Bin Program

- What can go in my green bin?
- Fruits, vegetables
- Dairy, eggshells
- Bread, cereal, grains, rice, pasta, beans
- Meat, bone, fish, shells
- Coffee grounds and filters
- Food soiled paper products
- Yard waste, flowers, and clean untreated wood
- Natural wood chopsticks (clean, untreated, not lacquered)
- Natural corks







Green-Bin Program

- What NOT TO Place in Green Bin?
- Plastics
- Products labeled "biodegradable" or "compostable"
- Glass
- Produce stickers
- Rubber bands
- Twisty ties
- Plastics, waxes, coatings, etc.
- Pet waste
- Pet litter

Curb Your & LEMINION Food Waste LA

Shop smart, waste less, recycle the rest.

Welcome! You are part of a food waste prevention and food scraps recycling pilot program that includes approximately 18,000 households in 25 neighborhoods across the City of Los Angeles.

A typical household wastes about \$1,500 per year on food that isn't eaten. When uneaten food ends up in the landfill, it creates greenhouse gases (GHG) that contribute to climate change. Preventing food waste in the first place helps reduce our GHG emissions and saves you money. If each household in this pilot participates for one year, we can reduce the amount of GHG emissions equivalent to eliminating 10,000 cars from the road. Recycling food scraps promotes a healthier, more sustainable LA.

During this one-year pilot, you will learn how to:

- · Prevent food from being wasted
- Use your Green Bin to recycle your food scraps Home compost more effectively
- Your participation in this pilot program is helping Los

Angeles prepare for the future. Statewide targets for reducing organics disposal and increasing food recovery take effect starting in 2020.

Recycle the Rest: Put food scraps in your Green Bin

After you've done your best to use what you bought, recycle any remaining food scrap

Follow these three simple steps to use your Green Bin for food scraps:

- 1. Collect food scraps in the kitchen pail provided (or a container of your choice).
 - Remove all packaging (plastic wrap, produce stickers, twist ties, foil. containers) and put food scraps only in your kitchen pail.
- 2. Empty your reusable kitchen pail into your Green Bin as needed throughout the week
 - It's no different than taking out your trash; take the pail out to the Green Bin and empty the food scraps into your Green Bin.
 - Keep the Green Bin lid closed.
 - Take the pail back to your kitchen and rinse it after emptying.
- 3. Take your Green Bin to the curb the morning of your collection day.







Tips for preventing pests, odors, and mess Inside your home:

- Use a paper towel to line your kitchen pail.
- Sprinkle baking soda in your kitchen pail to reduce odors.
- · Empty your kitchen pail into your Green Bin regularly and just before collection day.
- Wash your kitchen pail regularly. It is dishwasher friendly
- · Wrap smellier items and store in your refrigerator or freezer until pickup day.

Outside your home:

- Put some vard trimmings in your Green Bin before and after adding food
- Place the Green Bin out for collection every week, even if not full.

Residential In-Sink Food Waste Pilot Program

HOW TO USE YOUR GARBAGE DISPOSAL



01. Turn on cold water.



02. Turn on your disposal.



03. Slowly feed food scraps down the disposal. Avoid putting large pieces and large amounts of food waste. Keep your hands away from the disposal.



04. When finished, turn off your garbage disposal, and then allow water to run for a few moments to clear the drain.

What is the City doing to rescue edible food and reduce the amount of material going to landfill?

- Partnership with Food Rescue Organizations
 - 23 non-profit partners
 - Funding for Food Rescue
 - □ \$2 Million+ support to partners
- Food Insecurities
 - 16,680 tons of food rescued
 - Equivalent to 27.8 million meals
- ☐ Starting 1st quarter 2023 \$1million additional food rescue program funding for local grants

City of Los Angeles Single-use Plastics Reduction Ordinances

Pacific Palisades Community Council Board Meeting January 26, 2023



GOALS OF THE ORDINANCES



Reduce the amount of plastics waste which cannot be composted or recycled in the City of Los Angeles Reduce the amount of plastic waste that pollutes our waterways, groundwater, and even our bodies.

Encourage the use of reusable packaging, containers, and reusable bags.

Improve the aesthetics of our community and eliminate the risk to wildlife.



Zero Waste City Facilities and Events Ordinance

- Curtails the production of solid waste during City-sponsored events and at City-owned facilities by
- Reducing food waste,
- Preventing the usage of nonrecyclable foodware and other non-recyclable materials,
- Promoting the use of reusable and/or recyclable or compostable materials.





Reusable Foodware and Foodware Accessories

- Prohibited from providing disposable foodware for dine-in meal service or catered service.
- No single-use/disposable beverage cups would be allowed.
- Water will no longer be provided in plastic bottles or in disposable cups
- Required to provide hydration or bottle refill stations.

Food Waste Reduction

- Donate eligible surplus edible food to a food rescue organization
- Prohibit disposal of any surplus edible food
- Organic waste collection is made available at all City-sponsored events.

Other Waste Reduction

- All informational literature printed on paper distributed at community events or catered events would be required to contain a minimum of 30% post-consumer recycled content.
- All promotional items given away at community or catered events would have to be functional and not made of plastic or any synthetic fabric.



Expanded Polystyrene (EPS) Ban Ordinance

Prohibits the distribution, offer, provision, rental or sale to any person:


- EPS products intended primarily for food service;
- EPS egg cartons and food trays;
- EPS coolers and ice chests that are not encased in a more durable material;
- EPS shipping materials including shipping boxes, loose fill packing materials (e.g., packing peanuts), molded packaging materials.



What is Required For Compliance?







Requirements:

 Businesses to replace EPS items with alternatives.

Compliance Deadlines:

- April 23, 2023 for large food or beverage facilities or large retail establishments (with more than 26 employees)
- April 23, 2024 for all other food or beverage facilities or retail establishments



Single-Use Carryout Bag Expansion Ordinance

Expands the types of businesses that are prohibited from distributing single use plastic carryout bags to customers at these "shops":

- Apparel stores,
- Farmers' markets,
- Food or beverage facilities,
- Hardware stores, and
- Open air markets.



What is required for compliance?



Requirements:

 Businesses can either provide customers a reusable bag for free or a charge or charge customers a \$0.10 fee for a recyclable paper bag.

Compliance Deadlines:

- **January 23, 2023** for large shops (with more than 26 employees)
- July 1, 2023 for all other shops
- Quarterly reporting starting on July 1,
 2023 for large shops

Bottled Beverage Ordinances

- · Ban the sale of water in plastic bottles that are not refillable.
- Ban the sale of Los Angeles-sourced water outside of Los Angeles due to drought conditions.
- Mandate post-consumer recycled content in all plastic bottles.
- Mandate leashed-lids on plastic beverage bottles/containers.

Reusable Foodware for Dine-In Services Ordinance

- Mandate reusable foodware for dine-in services;
- All cups, plates and cutlery utilized for take-out and delivery services, be domestically compostable.

Banning Disposal of Textiles Ordinance

Ban manufacturers and retailers (online and brick and mortar stores) from disposing of apparel and textiles.
