## Pacific Palisades Community Council Now Taking Applications for At-large & Area Eight 2nd Alternate Representative Positions

(Pacific Palisades, CA – August 25, 2023) — Pacific Palisades Community Council (PPCC) is pleased to announce the opportunity for residents, business operators or property owners in Pacific Palisades to apply to become a 2nd Alternate PPCC At-large Representative, and for residents of PPCC Area Eight in Pacific Palisades to apply to become 2nd Alternate Area Eight Representative on the PPCC Board of Directors.

The 2nd Alternate At-large and Area Five Representative positions have both become vacant due to recent resignations of the respective 1st Alternates. Persons now interested in becoming an Atlarge or Area Eight 2nd Alternate Representative must apply by submitting a Statement (details below); candidates for the positions will then be reviewed and nominated by the PPCC "Three Chairs" Committee and elected by the Board.

The persons elected as the 2nd Alternates in both positions will serve the same term as the respective primary At-large and Area Eight Representatives: Chris Spitz (At-large) and Reza Akef (Area Eight) – terms ending on September 30, 2024. Alternate Representatives are encouraged to attend meetings and to participate in the discussion of issues, but 2nd Alternates do not vote unless the Primary and the 1st Alternate are also absent.

Applicants for the At-large 2nd Alternate position must live, operate a business with a street address or own property in any area of Pacific Palisades. Applicants for the Area Eight 2nd Alternate position must live within the specified boundaries of PPCC Area Eight in the Palisades. Area Eight includes the Riviera section (north and south of Sunset), Paul Revere Middle School and the Polo Fields area south of Sunset. All interested persons must submit a Statement of any length which shall include the number of years residing in Pacific Palisades (or in the case of the At-large Alternate, the number of years residing in, operating a business or owning property in the Palisades); the number of years as a resident of Area Eight (if applying for that position); the number of years at the applicant's current principal residence and that address (Area Eight applicants); or the address of the applicant's current residence, business or property owned in Pacific Palisades (At-large applicants). The Statement must include the applicant's position on issues they believe are of importance to the community, and may also include a few biographical facts including any skills that the applicant would bring to PPCC.
