Pacific Palisades Community Council Now Taking Applications for Areas Two and Eight 2nd Alternate Representative Positions

(Pacific Palisades, CA – January 8, 2026) — Pacific Palisades Community Council (PPCC) is pleased to announce the opportunity for residents of **PPCC Areas Two and Eight** in Pacific Palisades to apply to become the 2nd Alternate Area Representative in one of these respective Areas on the PPCC Board of Directors.

Area Two includes Palisades Drive, the Santa Ynez Reservoir, Santa Ynez Canyon Park and all streets and roads, including all residential, commercial, religious and educational facilities, with access to Palisades Drive. **Area Eight** includes Riviera sections North and south of Sunset Boulevard, from Amalfi Dr. up to Allenford Avenue, the Paul Revere Middle School grounds, and the Riviera Country Club. The 2nd Alternate Area Representative positions for both these Areas are now vacant (longtime Area Two primary Representative Steve Cron has moved away permanently and resigned; the Alternate positions in Area Two have changed accordingly, leaving a vacancy in the 2nd Alternate position; the 2nd Alternate position in Area Eight has been vacant for some time).

Applicants for the Areas Two and Eight 2nd Alternate positions must have lived prior to the Palisades Fire and have either returned or intend to return to their principal residence address within the specified boundaries of the respective Areas in the Palisades.

All interested persons must apply by submitting a Statement of any length which shall include the number of years residing in Pacific Palisades; the number of years as a resident of either Area Two or Area Eight; the number of years at the applicant's principal residence and that address; and a statement of intention to return to the principal residence in the applicable Area if now residing temporarily elsewhere. The Statement must include the applicant's position on issues they believe are of importance to the community, and may also include a few biographical facts including any skills that the applicant would bring to PPCC. Candidates for the position will then be reviewed and may be nominated by the PPCC "Three Chairs" Committee and elected by the Board.

The person elected as the 2nd Alternate in either position will serve the same term as the primary Representative. Both terms will end on September 30, 2026. Alternates are encouraged to attend meetings and to participate in the discussion of issues, but 2nd Alternates do not vote unless the primary and the 1st Alternate Representative are also absent.
